

### Projected Revenue by Fund Source




This chart shows the total general purpose revenue Gazelle Union Elementary School District expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Gazelle Union Elementary School District is \$645,029, of which \$487,795 is Local Control Funding Formula (LCFF), \$56,231 is other state

funds, \$70,829 is local funds, and \$30,174 is federal funds. Of the \$487,795 in LCFF Funds, \$91,718 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).


General fund expenditures not included in the LCAP are used for general operating expenses including salaries and benefits, cafeteria, plant maintenance, utilities, transportation and supplies.

## Increased or Improved Services for High Needs Students in the LCAP for the 2022-23 School Year

In 2022-23, Gazelle Union Elementary School District is projecting it will receive \$91,718 based on the enrollment of foster youth, English learner, and low-income students. Gazelle Elementary has and will engage with educational partners on the use of funds provided through the Budget Act of 2021 that were not included in the LCAP by soliciting input and back and forth dialogue based on school data at Back to School night on September 9th, monthly scheduled staff meetings, monthly board meetings, school survey, individualized student meetings, and SELPA meetings. These meetings have participation from certificated staff, classified staff, school business personnel, parents, board members community, members and students. Meetings are held in person whenever possible but virtually when needed.

A description of how the LEA used, or plans to use, the additional concentration grant add-on funding it received to increase the number of staff who provide direct services to students on school campuses with an enrollment of students who are low-income, English learners, and/or foster youth that is greater than 55 percent.

Gazelle Elementary School is using additional concentration grant add-on funding to provide additional paraprofessional support in the classroom for instructional and social emotional support. Being a single school district with only 39 students, monies have been used to increase salaries and add time to existing staff schedules.

A description of how and when the LEA engaged its educational partners on the use of one-time federal funds received that are intended to support recovery from the COVID-19 pandemic and the impacts of distance learning on pupils.

Gazelle Elementary School District engaged educational partners on the use of one-time federal funds by soliciting input and back and forth dialogue based on school data at Back to School night on September 9th, regularly scheduled staff meetings, monthly board meetings, school survey, individualized student meetings, and SELPA meetings. These meetings have participation from certificated staff, classified staff, school business personnel, parents, board members community members and students.

We solicited input on the Learning Loss Mitigation funds. The outcomes of interactions with communities partners indicated the need for academic intervention, technology equipment including chrome books for distance learning, PPE, food delivery during distance learning, Zoom subscription and hot spots to support families with internet access.

Gazelle Elementary did not receive ESSER III funds.

### General Information

<p><b>General Description</b> Gazelle Elementary School District is a rural, two classroom, single school district serving 38 kindergarten through eighth grade students in Gazelle, California. GESD has three classrooms and a cafeteria with a sprawling playground and grass area. The campus is tucked between cow pastures with a picturesque view of Mt. Shasta and the surrounding Shasta Valley. Families appreciate the smaller school setting with a family feeling compared to larger schools in the area. Transportation is provided to and from school for all students.</p> <p><b>Education Program</b> GESD has two general education teachers for two multi-grade classrooms, kindergarten through third grade, and fourth through eighth grade. Special education services are provided through the Siskiyou County Office of Education. Gazelle offers a robust after school program funded with ASES dollars that is open and free of charge to all students. Our Safe Afterschool For Everyone (SAFE) program is open to all students from the time school releases until 6:00pm daily.</p> <p><b>Demographics</b> 100 percent of our students come from socio-economically disadvantaged households as of 2021; as a result our school nutrition program is provided free to all students. Meals include breakfast, lunch, after school snack. We do not have any English Learners or Foster Youth students. Ethnic makeup of the student population includes 75.7% white students, 5.4% multi-race, 5.4% Hispanic and 8.1% American Indian. (California School Dashboard, 2021)</p>

## Reflections: Successes

### iReady (Local Data)

In ELA, 32% of students have met a typical academic year of growth. Fifteen percent of students have received a stretch growth goal which indicates more growth than anticipated for one school year. In Math 58% of students have met a typical academic year of growth. Twenty-four percent of students have received a stretch growth goal which indicates more growth than anticipated for one school year.

At the beginning of the 2021-2022 school year, in math 8% of students were performing at grade level, 44% 1 year behind grade level and 48% two or more years below grade. In March of the 2021-2022 school year, in math 24% of students were performing at grade level, 46% 1 year behind grade level and 30% two or more years below grade. Sixteen percent of students improved to on grade level performance and students performing two grade levels or more below grade level decreased from 48% to 30%.

At the beginning of the 2021-2022 school year, in ELA 13% of students were performing at grade level, 34% 1 year behind grade level and 53% two or more years below grade. In March of the 2021-2022 school year, in math 24% of students were performing at grade level, 46% 1 year behind grade level and 30% two or more years below grade. Eleven percent of students improved to on grade level performance and students performing two grade levels or more below grade level decreased from 53% to 30%.

### Attendance Rates

In 2021-2022 Gazelle's average daily attendance is 83%.

### Suspension Rates

In 2021-2022, Gazelle's had one record of suspension. Dashboard rates for suspension are unavailable.

To maintain successes Gazelle will continue to use iReady, implement teacher collaboration for student data analysis multiple times per year to drive intervention plan. To continue to reduce chronic absenteeism student athletics will continue in the 2021-22 school year, robust science field trips will be implemented, PBIS will be implemented. We will continue to offer SAFE to all students for no charge. Parent communication regarding attendance will further support absenteeism.

## Reflections: Identified Need

### iReady (Local Data)

Based on 2021-2022 data, 76% of students are at least one year behind grade level in math and 83% of students are one year or more behind in reading.

### Attendance Rates

In 2021-2022 the attendance rate for all students was at 83%. Chronic absenteeism is a concern.

To address needs, we will continue to train teachers to effectively implement adopted curriculum, use iReady as an intervention and create engaging activities for all students.

The LCAP for GESD focuses on the state priorities including conditions of learning, engagement and student achievement through 3 goals; a maintenance of progress goal and two broad goals. # Engaging Educational Partners

Stakeholders that are involved in the creation of GESD's LCAP include: students, parents, staff, board members, parent advisory committee, and community members. The parent advisory committee was formed through a school wide survey for parent interest in this group. This interest survey was conducted in the spring and the parent advisory committee was briefed/consulted on the LCAP draft in May. Students were also surveyed to contribute toward LCAP creation. Parents and community members were surveyed for LCAP input. The school board was informed of the finalized LCAP at the regularly scheduled June board meeting and it was adopted thereafter. The SELPA was consulted on May 3rd during an LCAP SCOE training session. Students were consulted through surveys, individual conversations and through meetings.

Gazelle takes an ongoing approach to solicit stakeholder feedback. Being such a small community, the administration is able to have ongoing discussions with all stakeholders throughout the year to gain understanding of what is valued for all involved and incorporate these values into plans for school initiatives and improvement.

Stakeholder feedback included a desire for Siskiyou County Office of Education science days to continue, iReady to continue to be used as a local data. ## Goal Analysis [2021-22]

There were no substantive differences in planned actions and actual implementation. Relevant challenges in this goal were training new staff to implement CAASPP assessment. Successes were support from the Siskiyou County Office of Education allowed for easy access to science curriculum purchase.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

Material differences between budgeted and estimated actual expenditures include: \$3000 less was spent for SEL curriculum and professional development because PD was not offered and curriculum was acquired for a lesser cost than anticipated. In action 1.2 we received one time funding and were able to purchase more materials than originally planned. In action 1.4, an immediate safety need with door handle and locks was identified and a project was completed to solve the school safety issue.

Actions have been effective in making progress towards the goal of having and implementing standards aligned curriculum, maintaining facility and recruiting credentialed teachers.

Based on student achievement data (CAASPP and iReady) our low income students are performing below the all student group and shows 71% are below grade level in ELA and math. In order to meet the needs of our low income students, we are implementing actions 3.2, and 3.5 to provide for intervention in ELA and math. Aides (actions 3.4 & 3.7) will also support student academic needs by providing extra academic supports.

Attendance rates show that students are not fully engaged in school and to address that need, action 3.3 is being implemented to provide hands on and engaging science instruction. Aides (actions 3.4 & 3.7) will also support student engagement by providing academic intervention.

Based on information indicating that children in poverty also have need for additional social emotional support, which is also seen at Gazelle Elementary, action 1.7 will be implemented to provide additional student support. Aides (actions 3.4 & 3.7) will also support student student social emotional well-being by providing small group and individual student check ins.

A description of how services for foster youth, English learners, and low-income students are being increased or improved by the percentage required.

The cost of the above actions collectively is \$96,761, which equates to 25.39%. This exceeds the increased and improved service requirement percentage of 24.07%.

After assessing the needs, conditions, and circumstances of our low-income students, we learned that the attendance rate of our low-income students is 7 percent lower than the attendance rate for all students. (Needs, Conditions, Circumstances [Principally Directed])

In order to address this condition of our low-income students, we will develop and implement a new attendance program that is designed to address some of the major causes of absenteeism, including lack of reliable transportation and food, as well as a school climate that does not emphasize the importance of attendance. Goal N, Actions X, Y, and Z provide additional transportation and nutritional resources as well as a districtwide educational campaign on the benefits of high attendance rates. (Contributing Action[s])

These actions are being provided on an LEA-wide basis and we expect/hope that all students with less than a 100 percent attendance rate will benefit. However, because of the significantly lower attendance rate of low-income students, and because the actions meet needs most associated with the chronic stresses and experiences of a socio-economically disadvantaged status, we expect that the attendance rate for our low-income students will increase significantly more than the average attendance rate of all other students. (Measurable Outcomes [Effective In])
