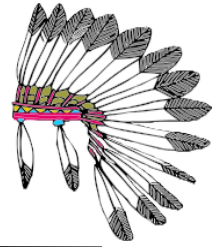

The law limits the response of Board members and prohibits the Board from taking any formal action on issues raised during public comment time.
